- Martin Tremblay Partner Research Program, a list of eligibility and information is available on the website: <u>https://arcticnet.ca/</u>
- The call is until December 20th
- The Partnered Research Program supports projects that address ArcticNet's key priorities in Well-Being, Infrastructure, Energy, Ecosystems, Economy. Eligible recipients include:
  - Post-secondary institutions;
  - Research hospitals;
  - First Nations, Inuit and Métis and Territorial organizations and governments;
  - Research networks;
  - Public engagement networks;
  - Companies that deliver public engagement activities;
  - Start-up companies (including those housed in Canadian post-secondary-linked incubators); and

- Dante Torio, CERRI just completed the feasibility study, 2-year program (with ECCC0 north of LaGrande up to Cape Jones)
- People are preferring IPCA over NMCA
- Guardians Program is continuing extending to gather more information about the practicalities of Protected Areas north of Chisasibi, south of Chisasibi has already been approved by the Grand Council and the Feds
- Hoping to expand our sampling area with the Northern Contaminants Program; we plan to cover areas south of Chisasibi next year
- Maude 24,000-26,000 kms2 Eeyou Istchee NMCA/IPCA (co-designation) feasibility study has been approved
- Lynda Orman will include an email with updates to the group

- Hosting a Community-based Monitoring Session at ArcticNet (5 speakers)
- Alessia two students went up to Sanikiluaq to work on water sampling
- Tanya biodiversity and monitoring project, carbon samples, early 2025 will hopefully have something to share
- Have some funding for bio blitzes to fill in gaps from their data
- The Hub is working on setting it up for each community to reflect their needs (through data sharing agreements) and keeping full autonomy over their data
- Hired a SIKU coordinator

- A new working group with Emergency Response in partnership with CCG launching in October
- Rebranding the Consortium with a new name and logo
- Website is being re-launched in February
- Newsletter launched

## 5) Roundtable Update

- Save the date went out last week
- Roundtable 2024 focused on Emergency Response
- Roundtable 2025 is focused on Research and Monitoring
- Agenda development: looking at space for small scale community fisheries
- Representation from all communities around Hudson Bay and James Bay and an opportunity to get updates on community priorities
- More time for in-depth discussions on a smaller range of issues
- Continuing with the youth delegation through support from the regions

# 6) Building the Agenda with this WG

- The Secretariat is putting together an agenda to be reviewed by this group
- New initiatives or programs that have had significant updates
- Further the work and discussion between regions and communities
- Mushkegowuk is scheduled to present on their research and monitoring efforts in their Area of Interest
- Colleen bring in the research and monitoring happening around Indigenous Stewardship and Protected Areas
- Potential side meeting for the youth to allow for a more flowing discussion
- Inviting feedback on ways to make these meetings as successful as possible last year's was longer coffee breaks, this time, no evening events, but a space to hold a more focused group during the evenings if wanted
- Molly putting together project list and an inventory of who is doing what where
- We will be sharing that map at the Roundtable, hopefully will be able to share it with this group beforehand
- Molly, youth tried to organize activities for just the youth thinking they would feel more comfortable with their peers; this particular group thought they were being segregated and wanted to learn from community members (mix of opportunities for youth to be part of the big group and their own group) a concrete skill that they could leave the event with
- Training for youth a way to really engage youth in community based research and monitoring
- Colleen: Youth could have their own panel potentially; would just need to prepare for it with them
- Talk about what some of the needs are for training with a youth panel
- Something more applied in a sidebar with them
- Think about knowledge transfer how can we recognize that many of the community leaders want to pass the torch to the next generation of leaders
- Trying to advance the overall involvement of youth in their community-led initiatives
- Martin one-on-one discussion, agencies to present something on a poster and invite people to see what funding is accessible/eligible, etc.
- Ryan we will have the graphic illustrator at the event again, will share the resources again across our social media platforms and our website
- Dante Leadership involving the youth if we could invite an elder/leader, who could have a leadership role in one of the communities and talk to the youth about it (side event); help the youth realize their role within the community, help youth realize their importance in their communities
- Serena Indigenous knowledge and integration with community research and monitoring and western science

- Sharing values (ownership, stewardship, determination)
- Molly data sovereignty, data sharing agreements, OCAP principles, especially in communityled, community-driven research with external partners - be clear about who can use the data and how (some previous work: <u>https://indigenousclimatemonitoring.ca/wp-</u> <u>content/uploads/2022/01/Guidance-Document-for-Community-Knowledge-Protocols-and-Data-Sharing-Agreements1.pdf</u>)
- Alessia would be great to include this in the roundtable discussion including how to proceed as universities, external partners, etc.
- Tanya Mushkegowuk is interested in developing policy beyond agreements (how have other people done it, how do we negotiate with provincial governments for permitting)
- New research authority in Nunavik The Secretariat has asked if they want to make a presentation
- Dante how to have more collaboration with Inuit communities
