### Notes on Agenda Items:

#### 1) Recap and Review of 2025 Roundtable

- Ryan Barry Received positive feedback from participants
  - Appreciated opportunity to meet in person and hear from community experts on the theme of research
  - Great participation from youth delegates can we have even more participation at the Summit?
  - Many consistent themes in the shared priorities, such as the effects of climate change and its impact on Emergency Response.
  - A report on the community priorities and a summary is available on the website
- Serena Panaktalok Appreciated youth participants and Maude Durand's leadership during the panel discussion.

# 2) Update and Discussion of Summit 2026 Planning

- Funding is secured, Targeting late Feb 2026, likely in Ottawa
- Summit will bring 3 reps per community and include updates from all working groups

#### 3) Co-Developing a Work Plan for Emergency Response Working Group

- Intend to formalize what the outputs of this working group will be. Previous ideas:
  - Create community of practice: Best practices for establishing and sustaining community-based CCGA / marine SAR units
  - Identify and assess mental health supports for first responders
  - Explore incorporation of Indigenous medical practices into emergency medical response
  - Develop prevention and safety materials (e.g. loading beluga onto canoe)
  - o Determine how to break down the barriers to reporting
  - Research and develop strategies for marking dangerous waters with buoys or other markers
  - Examine the impact / potential of new and emerging technology
  - o Determine how to engage local groups in spill response
- John Coyne Has worked on mental health services for emergency responders. Willing to help with this.
- Calvin Pederson Supportive of integrating Indigenous medical practices into Emergency response. Many limbs have been saved through these practices and there is science behind them. Shared personal experience of having his face saved by his uncle.
- Joel Heath New and emerging technology: streamlining products for situational awareness. E.g. how can reports on SIKU make it to CCG and EMSA?
- Peter Kikkert Worth knowing what technology options exist for communities
- Kevin Knapp Environmental response

- Spills: want to review first drafts of integrated regional plans at Summit
- Community marine response team project: how do we integrate new and emerging risks? Good moment with current infrastructure push in the region. Will need to update regional risk posture.
- Outputs: are there things communities need from Environmental Response? Ex:
  - Training local responders in oil spill response
  - Identifying groups that need training outside of the Auxiliary
- Steve Thompson Community of practice for SAR
  - How do we sustain, not just establish capacity in communities? No one-size-fits-all solution. Need to hear from communities what works for them and what is required from CCG to ensure they're prepared.
  - Prevention and Safety Materials. Also need to be regionally specific. Examples: how do you safely transport quarried materials, or loading beluga into a canoe?
- Peter Kikkert Where to place buoys: how does it fit with RAMSAR, other infrastructure development?
- The group agreed that none of the previous priorities should be removed from the list. Additional ideas shared included:
- Craig Lingard Create arctic boating safety approach in collaboration with TC and Inuit Nunangat communities. Provide education and make aware of available equipment.
   Focus on prevention.
  - Peter Kikkert Need to consider how long of a timeline would be required for the task
  - o Roch Anctil Second Craig's idea. Our actions should serve a real purpose.
- Daniel Kablutsiaq (presented by Peter)
  - Focus on emergency prevention education for youth.
  - o Consider how to keep responders in community during the summer
- Serena Going through best cases for each community. What has gone well and what hasn't?
  - Peter Kikkert Using case files? Or anecdotal?
  - Steve Thomson Anecdotal may be preferable. Can consider a format for this setting and what cases could be fruitful before the next meeting.
  - o Peter Kikkert We are working on something similar in Ungava Bay
  - Alexandre Lemarre something similar for spills could be very useful. Could provide a presentation on mitigating spill impacts using cases and showing science behind it
  - Miguel Parent TC is also interested in case studies for developing best practices. Can the case studies be revised after best practices 2 summits down as a table top activity?
- Peter How will we communicate? Can the Consortium create simple infographics as educational materials for the public?
  - Camille LeGall-Payne Second this. Also for the purpose of managing expectations - helping share what's feasible in what environments (e.g. Extreme tides, or likely response times)

#### 4) Discussion of Developing Working Group Terms of Reference

- Peter Kikkert Propose keeping the WG as one group instead of splitting into 2. No opposition from the group.
  - Ryan Barry Can circulate targeted agenda well in advance so that people can determine if it's relevant to them to attend a specific meeting
- Ryan Barry Each Working Group has a simple Terms of Reference (TOR) to help people know what to expect when joining, help define focus and what people get out of it.
  - Secretariat can put together draft TOR for this WG and bring to next meeting for review

  - Continues to work on SAR interagency collaboration. Working on Jurisdictional initiatives, such as land-ice interface. Most pressing event is SAR Scene:
